2.- PROCEDURE, PURPOSE AND RECIPIENTS

All the information requested in the contact form must be completed truthfully.

- Personal data of the applicant.

Personal data is provided directly by the interested parties in order to manage the request for information. We may collect personal identification and contact information.

Finally, information will be sent electronically on the future activities carried out by the entity to those interested who, duly informed during the data collection, do not oppose it.

- Information requestors

The personal data comes from the interested party who provides them to us by completing the contact form on the website, by calling us by phone, by sending us an email or through inquiries on the social networks in which the entity has a presence.

This data is used for the purpose of resolving queries and providing commercial information to those who demand or expressly authorize it, mainly through email.

3.- LEGITIMATION AND CONSERVATION

Legitimation - First, we can process the data because the interested parties themselves or their managers provide it to us to manage their registration as a user on the web.

We also ask these people for permission to process their data, for cases in which current legislation requires it, mainly in relation to the sending of commercial emails.

Finally, sometimes some law will ask us to present or keep certain documentation in which personal data of our clients can appear such as the General Tax Law, so we must treat that data in compliance.

Conservation - Once the data is not necessary for the purposes for which it was collected, it will be kept available to the competent public administrations, judges and courts during the legal conservation periods, that is, as long as a law may require us to present them. Once these periods have expired, they will remain blocked until their subsequent destruction or deletion is possible.

4.- RECIPIENTS OUTSIDE THE EUROPEAN UNION

We do not transfer personal data to third parties nor do we have suppliers that provide us with services based outside the European Union.

5.- CONSENT

The consent for the following treatments is collected in a free, specific, informed and unequivocal way through boxes on the forms themselves.

In addition, if you do not wish to receive email communications, you can easily object to the same forms.

6.- RIGHTS

You will be able to:

- Withdraw your consent or exercise your rights to:

- Access, or know what personal data we treat about you.

- Limitation, or to restrict the treatment we perform.
- Portability, or that we provide your personal data.
